Nicolas (Nico) Kanter kembali dipercaya menjadi Presiden Direktur Perseroan pada Rapat Umum Pemegang Saham (RUPS) Tahunan pada 4 April 2018 setelah diangkat menjadi Presiden Direktur Perseroan untuk pertama kali pada RUPS Luar Biasa tanggal 27 September 2011. Sebelumnya, beliau menjabat sebagai Komisaris Independen PT Vale sejak 17 April 2009.

Sebelum bergabung dengan PT Vale, Nico Kanter menjabat sebagai Head of Country, BP Indonesia sejak tahun 2007, dimana beliau mengawasi dan bertanggung jawab untuk mengintegrasikan seluruh operasi BP di Indonesia. Sebelum itu, beliau adalah Executive Vice President, Sumber Daya Manusia dan Hubungan di BP.

Nicolas (Nico) Kanter was re-appointed as President Director of the Company at the Annual General Meeting of Shareholders on April 4, 2018, after his first appointment as President Director on September 27, 2011. Previously, he served as an Independent Commissioner of PT Vale from April 17, 2009.

Prior to joining PT Vale, Nico Kanter served as Head of Country, BP Indonesia from 2007, where he supervised, and was responsible for, integrating the entire BP operation in Indonesia. Before this, he had been the Executive Vice-President, Human Resources and Relations at BP.

Nico Kanter mengawali karir di BP Indonesia sejak tahun 1984 sebagai penasihat hukum. Sejak tahun 1987 hingga 1999 beliau berkarir sebagai pimpinan di berbagai departemen termasuk Pembelian, Keuangan, Perencanaan & Pengendalian, Pemasaran & Komersial, HR dan VP Public & Government Affairs.

Setelah itu beliau menjabat sebagai Human Resources Manager pada tahun 1996 hingga 1999. Beliau menjabat sebagai Senior Vice President Human Resources & General Support di Vico Indonesia (diakuisisi oleh BP) pada tahun 2001 sampai 2002, dan sejak 2003 ditugaskan di BP Asia Pacific & Middle East (Hong Kong) sebagai Executive Assistant bagi Group Vice President Upstream.

Nico Kanter meraih gelar magister dalam bidang Hukum dari Universitas Indonesia dan gelar master dalam Administrasi Bisnis (Bisnis Internasional) dari University of Southern California, Amerika Serikat.

Nico Kanter started his career at BP Indonesia in 1984 as a legal adviser. From 1987 to 1999 he worked as head of various departments including Purchasing, Finance, Control & Planning, Marketing & Commercial, HR and VP Public & Government Affairs.

After this, he served as Human Resources Manager from 1996 to 1999. Mr. Kanter served as Senior Vice-President of Human Resources and General Support at Vico Indonesia (acquired by BP) from 2001 to 2002, and since 2003, he was commissioned by BP Asia Pacific and Middle East (Hong Kong) as the Executive Assistant to the Group Vice President Upstream.

Nico Kanter earned a Master's Degree in Law from the University of Indonesia and a Masters in Business Administration, in International Business, from the University of Southern California, USA.
